We offer reliable access to a variety of cryptocurrencies, including Bitcoin. We aim to track the most valuable cryptocurrencies monthly and assess them for specific risks and market capitalisation. Therefore, our fund provides safety and simplicity on par with traditional investment institutions.


Swing trading with strict risk control enables us to benefit from a moderate risk appetite in a highly volatile market.

Every single asset represents less than 5% of the fund's total investments, and the risk per one trade does not exceed 0.5% of the fund's capital.

The high volatility of the cryptocurrency market allows for a profit-to-loss ratio of 3-to-1 or more.

Each position has a defined Stop Loss and Take Profit.




ONLINE POSITION TRACKING


